ORDER

An order was issued vide no. HFW-27011-/15/2018/12374A (21), dated: 03-03-2020 based on the resolution of Executive Committee meeting of West Bengal State Health & Family Welfare Samity, regarding the maximum age limit for engagement and maximum age limit for renewal of contract of all contractual employees including Medical Officers (Specialists/ GDMO/FTMO/PTMO) under National Health Mission.

Due to shortage of Medical Officers in various health facilities, requests from different quarters were received for relaxing the maximum age limit for engagement as well as renewal of service tenure of Medical Officers (Specialists / GDMO/FTMO/PTMO/Physician).

After active consideration as per recommendation of a Committee formed for this purpose and approval of competent authority, the maximum age limit for engagement as well as renewal of service of the Medical Officers (Specialists / GDMO/FTMO/PTMO/Physician) is revised as detailed below:

1.	Maximum age limit for engagement	62 years	67 years
2	Upper Age limit till which service tenure can be renewed	65 years	70 years

- This order will be applicable only for the Medical Officers (Specialists/ GDMO/FTMO/PTMO) of service delivery under NHM / XV-FC.
- The upper age limit criteria for renewal of service tenure will be calculated as on 1st April of the given Financial Year.
- 4. The upper age limit till which service tenure of Medical Officers can be renewed as mentioned in the above table is subject to mental and physical fitness of the incumbent which will be certified by the immediate Reporting Officer of the Medical Officer of the respective facility.
- 5. All concerned are being informed for compliance.
